The schedule of judgments on the reverse side will determine the amount you will owe. Should your offense not be listed, contact the Clerk's Office at 260-724-5312 during business hours.

PROSECUTOR'S INFRACTION DEFERRAL PROGRAM

The Adams County Prosecuting Attorney offers Infraction Deferral of traffic tickets to qualified individuals. The program requires participants to sign a contract with the Prosecutor's office and pay a non-refundable \$192.50 fee.
