Health department

As of Monday 7 positive cases and 1 death in Adams County. There are 11,686 positive cases and 569 deaths in the State of Indiana. The department continues to do COVID tracing and the staff has been answering calls and emails. They are getting the latest up to date information and contacting individuals if needed. Adams County is working closely with Jay County to address the population that overlaps between the two counties. They are working with the Indiana State Dept of Health officials to better serve the population through the pandemic. They are also continuing to work with long-term health care and home health facilities in the county to provide PPE as the need arises. The department got their supplies from the Indiana State Dept of Health and are now restocked.

EMA

The District 3 Healthcare Coalition has ordered over \$100,000 of PPE supplies. Adams County hopes to receive the supplies by the end of April and will be used by the sheriff and fire departments.

Emily has updated the schedule for security at the hospital.

Community Corrections

They are in need of masks and were referred to a company who makes them in Fort Wayne. They are trying to find short term solutions.
