

The Adams County Board of Commissioners met February 19, 2019 at 10:00 a.m. in the Adams County Service Complex. Present were Commissioners: Rex Moore, Kim Fruechte, and Doug Bauman; County Attorney, Mark Burry and County Auditor, Mary Beery.

IN RE: MINUTES

Upon a motion by Rex Moore, seconded by Kim Fruechte, for approval of the Adams County Board of Commissioners' Minutes for February 12, 2019 with the following verbiage added, the grant application must be turned into the State by the 15th therefore the letter had to be to Randy Lehman on or before that date. IN RE: AUDITOR'S REPORT

Payroll Claims

IN RE: HIGHWAY DEPARTMENT

Highway Superintendent, Lonnie Caffee, reported the crew began work at 6 a.m. yesterday due to the freezing drizzle and rain from Sunday afternoon. One truck went into the side ditch trying to get out of the way of a vehicle.

The department has been salting and sanding several places (Polk Street to 27, Minnich Road, and 33 and Salem Road) along Highway 27 within the State of Indiana right-of-way. Mr. Caffee understands that it is the state's job to salt and sand the areas but it does not get done if Adams County does not do it. Several accidents have occurred at the Polk street location. Mr. Caffee asked if we are assuming liability and should a letter be sent to the state notifying them it is their responsibility to take care of the locations.

Attorney, Mark Burry, stated if we are doing something that is not our responsibility as long as we are doing it correctly we cannot be liable. He added as a matter of caution a letter should be sent that they should check the location.

IN RE: COMMISSIONER'S REPORT


Commissioner Bauman informed the board a letter was received from Council on Aging Director, Michelle Lengerich. Her organization is submitting a grant application to receive federal funds for the acquisition of equipment. They are requesting assistance to obtain a mini-van equipped with a ramp to accommodate riders who must travel in a wheel chair. This will replace the existing 2013 Ford lift van which has accumulated over 100,000 miles. If the Commissioners wishes to comment on the application, Council on Aging must receive a written request no later than February 28, 2019.


