Cumulative Bridge

County Engineer, Tim Barkey, opened the following bids for culvert C-112, located on County road 500 E between 900 S and 1000 S.

Upon a motion by Kim Fruechte, seconded by Rex Moore, to take the bids under advisement. Motion carried.

Mr. Barkey submitted for approval a permit from CenturyLink to relocate phone cable on 400 E south of Piqua Road. This will need to be granted for the culvert C-089 project.

Mr. Barkey submitted the Adams Countywide Bridge Inventory load posting changes and restrictions. INDOT has increased their awareness and changed their limits. The load ratings follow the new INDOT requirements and have been completed by Butler Fairman & Seufert for all of the county bridges. As a result, 9 bridges require a load posting change and 1 bridge requires special restrictions. These are shown below:

- Bridge 5, which carries CR 600 East over Staub Ditch, is not currently posted. It is recommended to post this bridge at 25 Tons.
- Bridge 20, which carries CR 1000 North over Gerke Ditch, is currently posted at 15 Tons. It is recommended to remove the load posting of this bridge.
- Bridge 43, which carries CR 550 North over Holthouse Ditch, is not currently posted. It is recommended to post this bridge at 25 Tons.
- Bridge 58, which carries CR 500 North over Holthouse Ditch, is not currently posted. It is recommended to post this bridge at 25 Tons.
- Bridge 62, which carries CR 400 North over Holthouse Ditch, is not currently posted. It is recommended to post this bridge at 25 Tons.
- Bridge 106, which carries CR 200 South over Blue Creek, is currently posted at 14 Tons. It is recommended to lower the load posting of this bridge to 8 Tons.

Mr. Barkey reported at 14 tons it allows a school bus on the road but at 8 tons it does not. He has spoken with Adams Central Schools to notify them. This bridge is located over the Blue Creek ditch and has a single span of 70'. It was not on his list to replace and he recommended the board hire Butler Fairman & Seufert to survey and assign the project.

Upon a motion by Kim Fruechte, seconded by Rex Moore, for approval to use Butler Fairman & Seufert to survey and design the bridge B-106 project. Motion carried. Mr. Barkey will get them to expedite the project.

- Bridge 114, which carries CR 300 South over Blue Creek, is not currently posted. It is recommended to post this bridge at 25 Tons.
- Bridge 127, which carries CR 500 South over Luginbill Ditch, is not currently posted. It is recommended to post this bridge at 25 Tons.

Load Posting Changes

- Bridge 134, which carries CR 300 East over Wagley Farlow Ditch, is currently posted at 15 Tons. It is recommended to remove the load posting of this bridge.
- Bridge 75, which carries CR 400 West over Beery Ditch, is not currently posted. This bridge is an adjacent box beam bridge that has been widened with steel beams and a concrete deck. It is recommend to restrict traffic on this bridge from driving on any of the steel beams on either side of the bridge deck. In order to accommodate this, it is recommended to place temporary traffic barriers on the edges of the box beams so the bridge roadway is narrowed from 28'-9" down to 17'-0" clear roadway. The barriers should be placed so that they are supported by the concrete box beams and not the steel beams. We assumed a weight of 200 lbs/ft for each temporary traffic barrier and a width of 18" for our calculations. In addition, it is recommended to install Narrow Bridge signs at each approach to warn motorists of the reduced roadway width. Note: If this restriction is not put in place, the bridge would need to be load posted for 10 tons.

Mr. Barkey reported there are two options that we could utilize. The widening was placed on it in the late 80's and there are no plans available to show reinforcement or beams used. Two semis cannot pass at one time. He will get a contract this year for replacement and it will require an additional from Council.

Upon a motion by Kim Fruechte, seconded by Rex Moore, for approval to restrict it to one lane with a plan for replacement this year. Motion carried. Mr. Barkey will get them to expedite the project. He will get with a firm to narrow the roadway with barriers, sign properly as narrow bridge at intersections, flashing lights, and maintain the area until it can be replaced.

Butler, Fairman & Seufert recommend that the correct posting be installed at each structure and at the nearest intersection within the next 30 days. Restrictions should also be installed within the next 30 days. Our bridge inspection team will need photographs of the new signs and restrictions installed at each bridge to update the INDOT database. Photographs at the intersections are not needed.

Mr. Barkey stated bridges B-20 and B-134 have plenty of cover to remove the 15 ton sign and they are okay to be open to traffic.
